The College of Dentistry invites applications from qualified individuals for a limited term position at the rank of Assistant/Associate Professor in Pediatric Dentistry.

The successful candidate will be required to deliver didactic, pre-clinical and clinical teaching; supervise student research projects; initiate, lead and participate in research activities; compete successfully for external funding to support this research program; and undertake relevant administrative activities including meetings and committee work.

We seek candidates who have postgraduate specialty training in pediatric dentistry at the Masters or PhD level or relevant teaching experience in pediatric dentistry; an interest and ability to engage in scholarly activities as evidenced by established or developing research initiatives; a strong commitment to excellence in teaching and research; demonstrated effective classroom teaching skills and mentorship; clinical experience in pediatric dentistry; effective interpersonal and communication skills. Preference will be given to those who have been awarded a Fellowship diploma by the Royal College of Dentists of Canada or certification by an American Dental Association-Recognized Specialty Certifying Board.

Candidates must be licensed or eligible for licensure by the College of Dental Surgeons of Saskatchewan (CDSS) and are encouraged to familiarize themselves with Saskatchewan licensing requirements:
