

## **Diefenbaker Youth History & Governance Camp Waiver/Consent Form**

I understand that the Diefenbaker Youth History & Governance Camp program is designed to encourage an interest in politics and history and will involve hands-on activities. I understand that the camp commences each day at 9:00 am and ends at 4:00 pm. Camp organizers and their agents shall not be responsible for my son/daughter before or beyond the camp periods, unless I have paid and registered for before/after care, which extends my child's time at camp from 8:30 am to 4:30 pm.

I understand that neither the University of Saskatchewan, the Diefenbaker Canada Centre, the Diefenbaker Youth History & Governance Camp program, nor their respective employees or agents will be held liable for any injury to my child, or loss/damage of my child's property. I authorize the Diefenbaker Youth History & Governance Camp program to provide or cause to be provided such medical services as the University of Saskatchewan medical personnel consider appropriate.

I understand that my child is expected to abide by the rules outlined by the Diefenbaker Canada Centre, the Diefenbaker Youth History & Governance Camp program, and its staff. These rules include, but are not limited to: rules pertaining to verbal, emotional, or physical abuse of other participants or camp leaders, rules pertaining to the treatment of camp leaders and other participants with respect, rules pertaining to the Diefenbaker Canada Centre gallery and ensuring the safety of the items contained within, and rules pertaining to personal safety. I understand that if my child does not follow these rules, he/she may be subject to consequences that include, but are not limited to: removal from an activity, being sent home early, or removal from the remainder of the camp. I understand that if my child does not follow these rules, I may be expected to pick up my child before the normal ending time of the camp. The Diefenbaker Canada Centre reserves the right to refuse further participation without refund to any participant who violates these rules. Both I and my child are aware that there may be individuals within the Diefenbaker Canada Centre who may have allergies to peanut/nut products or perfumes/colognes, I understand that my child is expected to refrain from bringing/wearing said items into the Diefenbaker Canada Centre.

As the parent/guardian of the above participant, I have read and understood the terms and conditions outlined. The Diefenbaker Canada Centre reserves the right to cancel the camp due to lack of funds, number of registrants, or any other reason at its discretion and upon doing so, will refund the registration fee.
