I. Introduction

USURJ is an online, peer-reviewed scholarly journal featuring original work by University of Saskatchewan undergraduate students. Founded by undergraduate students, the journal celebrates undergraduate contributions to research. USURJ publishes high quality research and review articles written by undergraduates in all disciplines and professional colleges. All submissions are reviewed by established experts in the relevant field.

II. Review Process

Peer review is integral to USURJ's editorial process. It allows the Editorial Board to make informed, fair assessments of potential articles for publication and provides invaluable feedback to authors regarding strengths of their article and areas requiring improvement.

Please provide the names of at least two University of Saskatchewan faculty members with expertise in a related research area (excluding the author's supervisor or course instructor in which the research was conducted) to aid the Editorial Board in determining potential reviewers.

III. Authorship

All persons listed as authors must have

- made a substantial contribution to the concept and design, acquisition of data or analysis or interpretation of data;
- drafted the article or revised it critically for important intellectual content; and
- approved the version to be published.

In the case of multi-authored works, an undergraduate student or students must be the primary (first) author(s). Undergraduate students who contributed equally to the article and wish to share primary authorship may be listed with an asterisk (*) and accompanying note.

IV. Authors' Rights¹

USURJ is an open-access journal. Unless you indicate otherwise, articles will be published with authors holding full copyright protection. You may also publish under a Creative Commons license (see <http://creativecommons.org/licenses/>); you can make a final decision on licensing prior to final publication. Work submitted cannot have been published previously and should not be under consideration for publication elsewhere.
